- 1.1. This Cookie Policy explains how Sarasin & Partners LLP ("**we**", "**us**", "**our**" or "**ourselves**") uses cookies on our website. This Cookie Policy applies to everyone who visits our website, please read it carefully.

2. What is a Cookie?

- 2.1. Your internet browser has a feature called "**Cookies**" which store small amounts of data on your computer about your visit to a website and distinguishes you from other users of the website. They are widely used in order to make websites work more efficiently and to provide website owners with information about how the website is used. Cookies improve your browsing experience by:
 - (a) remembering settings so you don't have to keep re-entering them whenever you visit a new page;
 - (b) remembering information you have given (e.g. country of residence) so you do not have to keep re-entering it; and
 - (c) measuring how you use the website so we can make sure it meets your needs.
- 2.2. There are 3 types of cookies:
 - (a) strictly necessary Cookies – these enable users to browse a website and allow the features of the website to work correctly such as navigating between pages of a website;
 - (b) performance Cookies – these enable website owners to collect information on how visitors use the website such as which are the most popular pages of a website; and
 - (c) targeting Cookies – these are cookies that form part of technology which is provided or powered by a third party.

We do not collect or store your personal information (e.g. your name or address) so this information cannot be used to identify who you are. We do not allow Google to use or share our analytics data.
